"Suncorp and QLD Ballet customer promotion" Competition Terms & Conditions

- 1. This competition ("**Competition**") is conducted by Suncorp Corporate Services Pty Ltd ABN 69 074 966 466 of Level 28, 266 George Street, Brisbane QLD 4000 ("**Promoter**").
- 2. Entry to the Competition constitutes acceptance of these terms and conditions ("**Terms and Conditions**"). All entry instructions and prize information published by the Promoter form part of these Terms and Conditions.
- 3. The Competition is only open to patrons that purchase a ticket to Queensland Ballet's 2019 season of Romeo & Juliet before the end of the competition period at 5pm AEST on Friday 9 August.
- 4. Entry is only open to Queensland Residents aged 18 years or older.
- 5. The Competition commences at 9.00am AEST on Wednesday 23 July 2019 and closes at 5.00pm AEST on Friday 9 August 2019 ("the Entry Period"). Except as otherwise stated, all times are Brisbane time.

ENTRY

- 6. To enter the Competition an Entrant must:
 - (i) have purchased a season ticket or single ticket for Queensland Ballet's 2019 season of Romeo & Juliet before the end of the Competition Entry Period;
 - (ii) use a compatible browser to complete and submit the Competition entry form at www.queenslandballet.com.au/support/corporate-partnerships/suncorp-rewards/suncorp-rewardsromeo-and-juliet ("Competition Website");
 - (iii) and tick the box on the Competition Website to confirm they have read and agree to the full Competition Terms and Conditions.
- 7. Cost of entry via the internet is free, but internet connection and usage rates may apply. Entrants should obtain details of such costs from their service provider.
- 8. Entrants will be sent an email confirming the acceptance of their entry. If Entrants live outside Queensland, are not within the ages explicitly specified, and/or the entry does not comply with the Terms and Conditions listed, the entry into the Competition will not be approved/permitted.
- 9. Entry must be submitted in accordance with these Terms and Conditions, and only one (1) entry per person is permitted.
- 10. Entries must be received during the Entry Period. The Promoter takes no responsibility for late, lost, incomplete, incorrectly submitted, illegible or misdirected entries or for any delays or failures in telecommunications service or technical fault or equipment. Errors and omissions may be accepted at the Promoter's discretion.

PRIZE

- 11. Eligible Entrants will go into a random draw to win a 'Money-Can't-Buy' (MCB) experience with Queensland Ballet on Saturday 24 August 2019.
- 12. The MCB experience will be drawn at random from all eligible entries received during the Entry Period, for ten (10) winners (and one guest per person) to participate in the experience. The MCB experience will take place on Saturday 24 August 2019. The prize is valued at up to fifty dollars (\$50.00) per person (including 10 competition winners and their guest). WINNERS
